Legal Aid Society, Campus law Centre, Faculty of Law organized an Legal Awareness drive at Mukherjee Nagar, Munshiram dairy, which constituted thirty students from Ist, IInd and III rd year. Through this drive students were made to look into ground realities of various social problems of the people and their implementation issues. The major objective of the drive was spread legal literacy, provide effective solutions to the problems of the masses, and make them aware of the services offered at legal aid clinic at Campus Law Centre for further for queries in future. The students were accompanied by teacher members of the Legal Aid Society who played very effective role in resolving queries of the people.

The major issue or problems that have been faced by people are as follows:

1. Sewage problems
2. Pension
3. Marriage disputes (Section 9 of HMA act and 125 CrPc)
4. Drug addiction

Students provided satisfactory solutions and counselling to the residents through Five Teams (consisting of 2 boys and 3 girls each group) via door to door services which included distribution of pamphlets on domestic violence and bonded labour and free legal services offered by the the Legal Aid Clinic at Campus Law Centre and simultaneously provided solutions to various queries raised by them and provided free legal advice. Students were also provided with refreshments after the successful drive.

The students of the drive have resolved to follow the problems of the residents via filing of RTI's and writing to the concerned authorities in near future.

Case History: Major Issues to be followed up

1. It was found in certain families that they were unaware of the fact that their children aged between 6-14 years had a right to free education. One family told that they were paying fees for sending their children to the nearby Government school.

2. A family complained of being harassed by Government school authorities. In this particular case, the woman stated that on two occasions, when she had gone back to her village during the school vacations and for a month or two



had exceeded the vacations, the children's names were struck off the school records. When the family had tried to approach the authorities, in one case they were denied the right to give an explanation and in another case, they were told to make fake medical certificates for which they were charged 450 rupees. The family

complained of not being given sufficient explanation for striking off their ward's names from the school records. (GTB NAGAR SCHOOL).

3. Environmental Issue - A large dumping ground has been created and now been a source of disease and filthiness, and large amount of foul smell coming from it resulting in the fact that it becomes



very difficult for the residents to stand nearby it and live nearby it. Though number of complaints were being made to MCD, Local MPs and MLAs, Councilor but no action has been taken till yet.

4. Majority of the Senior Citizens were denied their pension. Some have been waiting since 2 years for their pension. Many complained of the treatment which they were subjected to in the government offices. Mrs. Kalawati who a widow and an estranged woman



in her old age had no means of income so as to live a meagre life, we also got to know about how she hasn't got her pension under the widow pension scheme started by the Government since 2014.
