ABSTRACT FROM ORDINANCE VIII-APPENDIX-IV

आर्डिनेंस VIII परिशिष्ट IV का सार

1. A candidate who had applied for admission to a University Examination mentioned in Ord. VIII Clause 4(b), if having completed the required percentage of lectures and being otherwise qualified to appear fails for good reasons to appear or having appeared is declared unsuccessful at the examination may, on the recommendations of the Principal of the College or the Head of the Hall or the Dean of the Faculty concerned, placed by the Registrar on the register of ex-students, subject to the following conditions :

जो परीक्षार्थी आर्डि- VIII धारा 4(बी) में उल्लिखित किसी विश्वविद्यालय परीक्षा में प्रवेश के लिए आवेदन कर चुका हो और यदि उसने परीक्षा में बैठने के लिए व्याख्यानों का अपेक्षित प्रतिशत उपस्थिति तथा अन्य अपेक्षाएं भी पूरी कर दी हों परन्तु फिर भी पर्याप्त कारणों से परीक्षा में बैठ पाये या परीक्षा देने के बाद असफल घोषित कर दिया जाये तो संबंध महाविद्यालय प्रधानाचार्य अथवा हॉल के अध्यक्ष या संकायाध्यक्ष की सिफारिश पर कुलसचिव उसे पूर्व छात्रों की सूची शामिल कर सकते हैं परन्तु उसके लिए निम्न शर्तें हैं :-

- (a) Subject to the limit regarding examinations which he/she may take and all other conditions as laid down in Ord. VIII, he/she may be allowed to enrol himself/herself as an ex-student and is allowed to take and pass the final year examination within six years from the year of admission to the first year class and five year from the year of admission to the second year class of B.A. (Pass)/B.Com. (Pass) Courses.

Page 282 Appendix to Ordinance-(VIII)

2. All applications for registration as an ex-student shall be made before a date to be prescribed by the Regulations.

3. *The fee for enrolment of Ex-Student shall be Rs. 500/- payable alongwith the application for registration as an ex-student for any particular examination in a year.

4. An ex-student on his/her registration may, on payment of the prescribed fee, be admitted to the respective examination on presentation of the required certificates including that of a good moral character given by some responsible person and countersigned by the Principal of his/her College.

NOTE : The term "his College" in this Ordinance means the College last attended by the student.

*An ex-student shall have to pay fee afresh if his/her name is to be borne on the register of ex-student.
