
September 2020:

Workshop on Legal Research and Methodology and Techniques to Use Manupatra




January 2021:

17th K.K. Luthra Memorial Moot Court, 2021






2021. Due to the COVID-19 pandemic, the competition was conducted virtually in an audio visual mode.

Workshop on How to Read & Approach a Moot Problem + Basics of Research



Workshop on Oral Advocacy & Court Mannerisms




Freshers' Induction Moot (FIM) 2021
