The programme commenced with Dr. Anita Yadav welcoming all the guest speakers and introducing them to the audience. After that, Prof. (Dr.) Raman Mittal gave the insights about Human Rights and welcomed the distinguished guests.



Following which Mr. Rajesh Gogna, Secretary General, Human Rights Defense International discussed with audience about Human Rights development in India and also shared his personal experience with or regarding to Human Rights. He shared one of his personal incident from Conference in Sri Lanka where he resisted when his luggage was picked up by some other person, considering it to be a violation of right to equality and in turn violation

of human rights. From his interaction with the teachers, fellow guests and the audience it could be easily gathered that he is against the basic hierarchy and established formalities and believes in Equality for all. He enlightened the students about the impact of casteism on the students, social and economic problems faced by women during pregnancy, the poor conditions of contractual workers and its direct correlation with the violation of basic human rights. He brought about the importance of freedom of expression. Through his views he touched upon every subject that is affected by the Human Rights violation. He informed the audience about the No Refugee Policy in India and interacted with the students about the possible provisions for the same.

It was a wholesome learning experience for everyone.





Then, Akshita (Student Co-Convenor) welcomed Ms. Rishika Srivastava, Ld. Secretary, Central DLSA and Mr. Bharat Chugh, Advocate, Supreme Court of India. Dr. Anita Yadav and Prof. (Dr.) Raman Mittal greeted both of the dignitaries with a sapling each as a token of appreciation.





Ms. Rishika Srivastava through her insightful words quoted several landmark judgements and dignitaries on the issue of human rights. She stressed about the DIGNITY, FREEDOM, and JUSTICE as bedrock of Human Rights. She talked about evolution of Human Rights in India and interacted with the students and also answered their questions.

She discussed about her participation in the Death Penalty Project and The Sanitization Programme with fellow Judges. She touched upon the difficulties and discrimination faced by the Transgender Community. She emphasized on the Theory of Justice and concluded her address by urging students, to be not afraid of doing the right thing for serving the purpose of justice.



Following which, Mr. Bharat Chugh was welcomed with a huge applause. He shared his experience as a civil judge and also his understanding in corporate field. He talked about his dilemma between Law and Justice. He urged students to have faith in The Constitution and laid emphasis on the importance of laws. He asked students not to take law at its face value rather test the law in practical situations. From his experience as a judge and later as a practicing advocate, he shared various cases in which there was an explicit violation of the basic rights of the individual. He summed up his address by answering to the various questions posed by the enthusiastic students regarding the interrelation of law and human rights.



The event concluded with Dr. Anita Yadav delivering a vote of thanks to the distinguished guests and the professors. Ma'am appreciated all the students for making the event a successful session and an interactive one.
