## **INTRODUCTION**

*“THE ESSENCE OF THE FUNDAMENTAL PRINCIPLES OF LAW IS EQUALITY BEFORE THE LAW, THE RIGHT TO COUNSEL AND THE RIGHT TO FAIR TRIAL. THIS IS ACHIEVED THROUGH ACCESS TO LEGAL AID FOR ALL”*

‘Legal Aid’ encompasses a broad range of activities that aim at social advancement by creatively utilizing the instrument of Law. Legal profession, the way it is currently practiced and organized, is primarily concerned with the improvement of the quality of legal services rather than ensuring equitable and even distribution of legal services. That is where the concept of Legal Aid finds its relevance, it strives to make law relevant to the masses that are somehow left out and exist below the visibility line of law in action.

At the Legal Aid Society of Campus Law Centre, University of Delhi (LAS) we want to provide legal aid to those who cannot afford professional legal services and we want to champion those public causes for which support is lacking. For this we have divided the functional areas of LAS into various groups like- Environmental protection, consumer protection, prison reforms, gender sensitization, victims of armed struggle, dramatics, slums, disabled/senior citizen, juvenile justice & child rights, mediation, right to information etc.

LAS has always been a pillar of support for those who require legal assistance. The progress we have achieved in this arena was the result of great work by the law students, the teachers and lawyers who were inspired by the legal aid ideals. Our cherished objectives include work on all the fronts of legal process, i.e., awareness, encouragement and enforcement of law.

## **VISION**

As Robert Ingersoll has rightly said “The hands that help is far better than the lips that pray.” The LAS, with a vision to extend legal aid or support in all manners needed, is dedicated to promoting an inclusive legal system by organizing various activities and programmes pertaining to public welfare. The far-reaching goal of these activities is to extend legal help to the marginalized, disadvantaged, and indigent sections of the society.

LAS’ focus is to accelerate the process of providing a platform to spread consciousness about the requirement of legal aid by the indigent litigants. This process involves engaging the student volunteers in organizing of various legal awareness drives, legal aid camps, campaigns, seminars, etc. Also, through these activities the society intends to make the residents of Delhi aware about their legal rights and duties.

The society in order to achieve the goal of establishment of an inclusive legal system facilitates the working of the LSC which functions under the aegis of Delhi State Legal Services Authority (‘DSLISA’). The function of LSC is to impart legal aid to the indigent litigants in the procedure of court proceedings and in any additional process for the same. The volunteers of LAS also assist the lawyer and the litigants during the meetings in the LSC.

One such community which is capable of bringing a change in the society is the student community. Therefore, the society is devoted in grooming the student members of the society to become responsible legal practitioners or officers that will be acquainted with the ground realities of the country and will work towards the upliftment of the disadvantaged sections of society by imparting all kind of legal services required by them.

We are open to ideas, and we believe that we can learn from the experience of those who are engaged in similar activities. For that we are keen to enter into collaborations with NGOs and governmental organizations. Our key strength, in this regard, is a large body of students who are talented and equally committed.

We do have a dream, a dream to create a society where none is deprived of legal rights.

## **LEGAL SERVICES CLINIC**



The Legal Services Clinic ('LSC') of Campus Law Centre, University of Delhi was inaugurated on the 27th of September 2014 by Hon'ble Mr. Justice A.K. Sikri (an eminent jurist and former judge of the Supreme Court of India). The activities of the clinic are aimed at organising legal awareness programmes and to facilitate accessibility of legal relief and free legal aid to the marginalised sections of the society in consonance with the provisions of the Legal Services Authorities Act, 1987 (LSA Act).

The sole objective of the clinic is to bridge the gap that exists between what the law promises to offer and the harsh realities of the legal world. It is medium for the students to avail the opportunity of not only applying their legal aptitude and judicial mind but also exposes them to the practicalities of the profession.

The LSC works in a close collaboration with DSLSA and is opened regularly on every Saturday from 10 a.m. to 1 p.m. A Legal Aid Counsel, appointed by the DSLSA, visits the clinic. There are always at least two PLVs available to assist the Counsel. This academic session, LSC has been functioning physically and consistently with a view to facilitate as much free legal aid as possible to the ones in need of it.



## **AWAAZ-THE BLOG**

Literature has the power to mould thought, influence people, and affect change. Recognising the importance of the written word, Legal Aid Society of Campus Law Centre in 2019 launched a blog called “Awaaz” to aid the society achieves its goals of making the law accessible to all persons. 'Awaaz' aims at providing the students with an opportunity to explore the legal arena and shape discussions relating to paramount and critical issues pertaining to legal aid. Awaaz intends to fulfil two purposes; it aims to provide a space to young writers to present novel insights to emerging fields of law and legal aid and simultaneously aims to create a learning platform for all the law students.

Law students are limited in their knowledge and experiences given the range of issues that concern those accessing legal aid. Awaaz seeks to be the platform that bridges the gap between the theoretical imagination of a legal issue and its practical implications on ground.

Awaaz exists as the knowledge centre of the Legal Aid Society where students can learn about various relevant and vital legal issues. As a result of this, the platform limits its selection process to accept only topics related to legal aid and other socio-political and legal concerns. The blog is dedicated to presenting itself as a primary source of information for all students, para-legal volunteers, and lawyers interested in learning about emerging and pertinent questions in the field of legal aid.

Awaaz was inaugurated by the Professor-in-Charge of Campus Law Centre, Dr. (Prof) Usha Tandon on 7th November 2019, which was the final day of Para-legal Volunteer training organised for selected students of Campus Law Centre by Delhi State Legal Services Authority. The blog invited submissions in the beginning of the year and since then it has received more than 150 submissions from various law colleges around the country. The topics on which submissions were received ranged from diverse themes including gender, politics, economics, sports, cyber laws, labour laws, criminal law, corporate law and various socio-legal issues like same-sex marriage, marital rape as a form of crime, adultery, mental health care in India, and the interaction of COVID-19 lockdown with the courts, and politico-legal issues like abrogation of Article 370 of the Indian Constitution, Critique on Death Penalty, Russia Ukraine Conflict, Hijab Ban, Question of Consent in Marital Rape and many more.

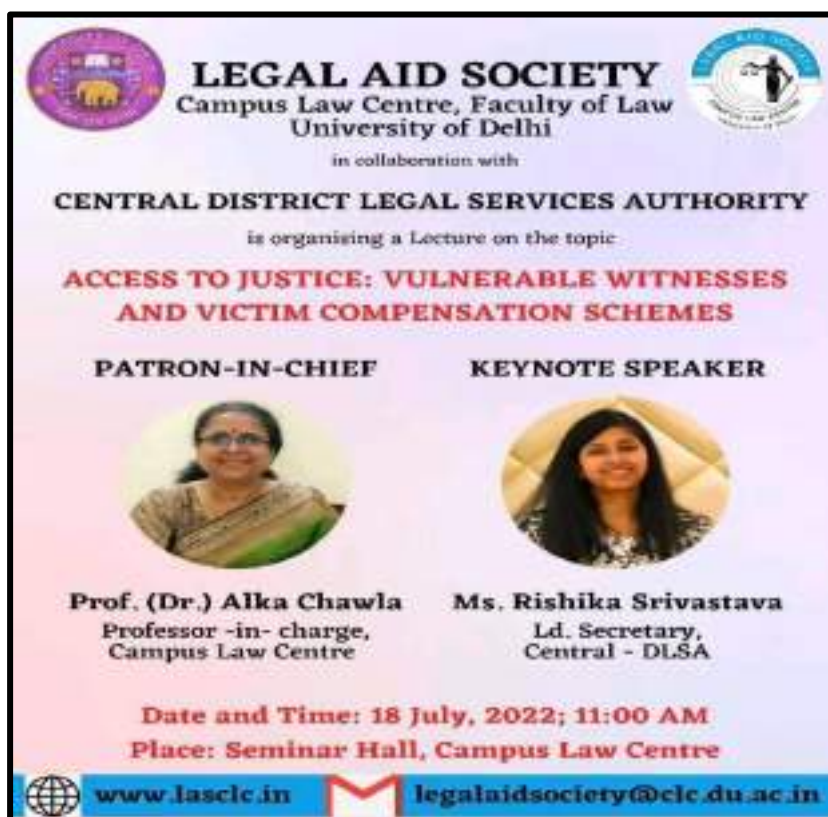

She has joined as full time Secretary, Central District Legal Services Authority, Tis Hazari Court, Delhi.

**Saurabh Kirpal** is an Indian senior advocate, **LGBTQIA+** activist, and author of a book. In November 2021, for the first time in the country, the openly-gay senior advocate was considered for appointment as a judge at the Delhi High Court by the Supreme Court Collegium. An alumnus of **Cambridge University and Oxford University**, he has an impressive resume consisting of countless landmark cases, including arguing the case of **Navtej Singh Johar V. Union of India** in the Supreme Court, which brought down Section 377. He imparted his knowledge and experience of working in the Indian Legal sphere with the students of Campus Law Centre and answered multiple queries regarding the future of LGBTQIA+ rights in India and the Indian legal system.

The project commenced from February and continued till August whereby the students of Legal Aid Society undertook awareness drives in slums and villages adjacent to Delhi and campaigned door to door to make people aware about **1516**, the free legal aid helpline number of DSLSA and how it can be used to approach the authorities. Another important field work undertaken by the students was regarding various schemes of NALSA & DSLSA, welfare schemes run by the government, fundamental rights as envisaged in the Indian Constitution and other general laws.

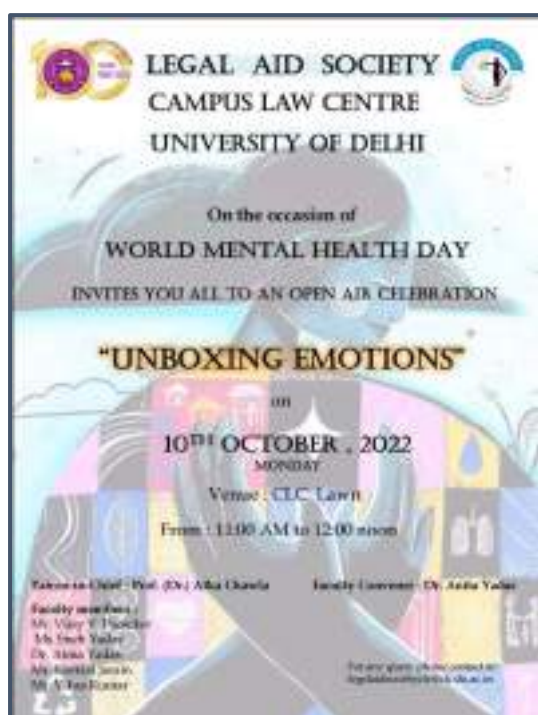

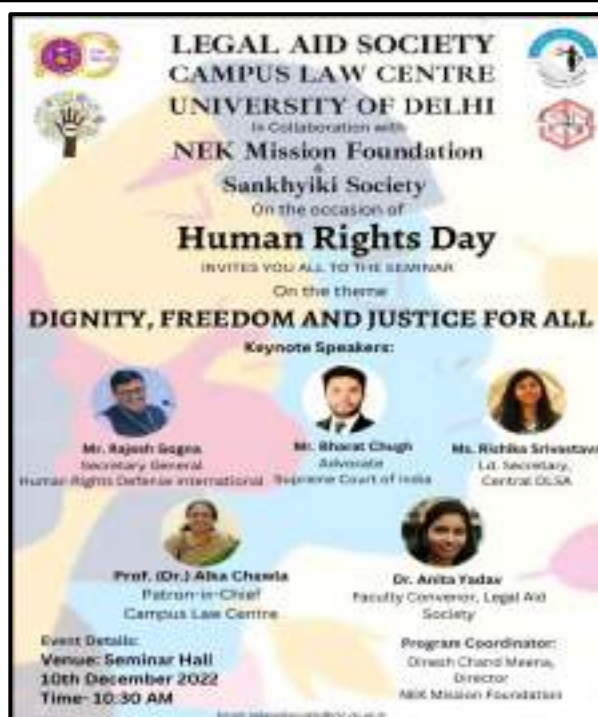

## **WORKSHOP ON ‘LABOUR CARD SCHEME’ OF GOVT. OF DELHI**

The Legal Aid Society in collaboration with ‘Neev-Foundation for Legal Aid’ organised a legal awareness workshop on the **Labour Card Scheme** run by the **Govt. of Delhi** on **13th Dec, 2022** in the Seminar Hall of Campus Law Centre in physical mode.

**NEEV Foundation** for Legal Aid is a public charitable trust founded in July 2020 to meet the need of access to justice for the marginalized communities through pro-bono legal services, including litigation, legal education, and quasi-legal support. It believes that a single action can make a considerable difference in the community, and that collective action can greatly impact the world.

Various speakers who came from NEEV-Foundation delivered an interactive workshop to inculcate the basics and the significance of labour card scheme among the student attendees.

Our first speaker was **Ms. Mishika Singh**, Founder of NEEV Foundation. She elucidated the purpose for the introduction of Labour Card Scheme by the Delhi Government in the year 2002 as the benefit of construction workers working in any construction site. She also made clear that all the benefits and facilities, such as Marriage Assistance, Old Age Pension and Funeral Benefit to nominee etc. are available only up to two children.



The next speaker was **Mr. Aman Uniyal**, Programme Officer of NEEV Foundation. He made the attendees aware about the Procedure and the Documents required for the application e.g.: Proof of Residence, Proof of DOB, Bank Account details, Self-Attested copy of the Aadhaar Card of the Beneficiary and Self declaration of employment and the basic details of Beneficiary as well as that of the contractor as well as that of the contractor.



The other guest was **Ms. Harshita Singhal**, Programme Officer at NEEV Foundation. She has been working as a full-time Programme Officer at Neev, supervising and managing the overall functioning of the Neev's flagship Mediation and Legal Aid Centre. **Ms. Ashsifa Zaidi**, Camp and Centre Coordinator at NEEV Foundation threw light upon the procedure for making the labour card as to what are the documents required for applying. **Mr. Shahzad Asgar Zaidi**, Community Worker at NEEV Foundation made us aware about the procedure for making the labour card.

## **PARALEGAL VOLUNTEERS TRAINING PROGRAMME 2023**



The Campus Law Centre, Legal Aid Society organized a three-day Para-Legal Volunteers (PLV) Training Programme for its students from 1st Feb – 3rd Feb, 2023 in collaboration with the **Delhi State Legal**

**Services Authority (DSLISA)** for induction of PLVs. The Session saw around 130 students in attendance. The students were selected on the basis of an eligibility test conducted by Legal Aid Society of Campus Law Centre.

First session of Day 1 was on the topic 'Role and Responsibilities of PLV by **Ms. Harshita Mishra, Ld. Secretary (Litigation), DSLISA**, wherein she enlightened the students about the responsibilities of a PLV. The second session by her touched upon the topic- 'Basic Structure of the constitution of India with special emphasis on



Fundamental Rights' in which she spoke about secularism, role of judiciary, importance of Article 21 and functioning of DSLISA and CDLSA. The third session was delivered by **Sh. K.B. Rai, Former Advisor, Administrative Reforms Dept, GNCT of Delhi** on the differences between the RTI act, 2005 and Delhi RTI, act 2001. The final session of the day was undertaken by **Mr. Bilal, Program Director, SPYM** on Drug Abuse amongst children- Indications and Rehabilitation of CNCP.



Day 2 began with a seminar on laws relating to women by **Ms. Anuradha Jindal, Secretary, South-West DSLSA**. She divided the session into three heads- Sexual assault, sexual harassment at workplace and rape. The second session was on ‘effective communication and interpersonal skills’ delivered by life-skills coach, **Mr. Vikas Chandwani**. The third session was given by **Ms. Rishika Srivastava, Ld. Secretary, Central DLSA** on ‘overview of criminal justice system’. The final session of the day was given by Adv. Ms. Alka Chojar on ‘overview of matrimonial laws’.



The final day of PLV Training began with the session by **Ms. Harshita Mishra, Secretary (Litigation), DSLSA**.

The Session focused on ‘Laws on Children with Special emphasis on Cybercrime’. The next session was about the schemes run by NALSA/DSLSEA, conducted by **Sh. Lalit Kumar Secretary, Central-II DLSA**. The



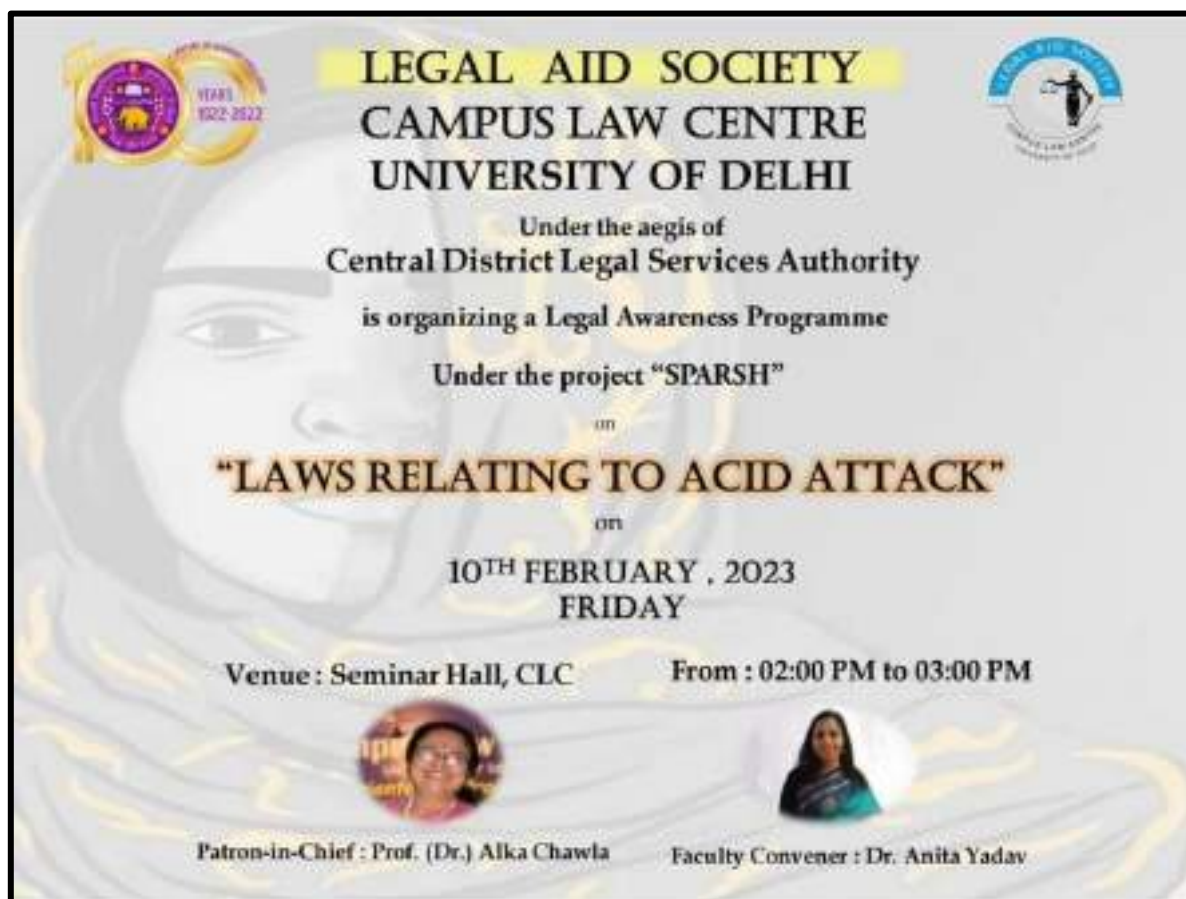
third session was about ‘Laws Relating to Senior Citizens and Transgender’ by **Ms. Helly Fur Kaur, Secretary New Delhi DLSA**. The final Session of the PLV Training dealt with a crucial topic “Overview of Labour Laws”. It was dealt with by **Sh. Himanshu Sehloth, Secretary, North DSLSA**. The Session dealt chiefly with Trade Unions Act, 1926, Industrial Disputes Act, 1948, Payment of Wages Act, 1936.



### **LEGAL AWARENESS SESSION ON ‘LAWS RELATED TO ACID ATTACK’**

The Legal Aid Society, Campus Law Centre (CLC) under the aegis of Central District Legal Services Authority organized a **Legal awareness Session on the laws relating to acid attack** on February 10 2023 from 2PM to 3 PM in Seminar Hall, CLC. This was part of **Project SPARSH** organized by CDLSA under the aegis of NALSA and DSLSA. The speaker of the session was **Advocate Gurpreet Kaur**.





The Session started with the plight of acid attack victims. The damage caused by acid attack is everlasting. The original face never comes back. It not only leaves a physical scar but also a lifelong mental trauma. Recognizing this menace, **Justice Verma Committee** in its Report made suggestions to include such offences under IPC. Accordingly, the 2013 Amendment inserted Sections 326A and 326 B in IPC, 1860. The speaker

drew attention of the students to the life after an acid attack. Over 100 plastic surgeries are required. Each surgery not only incurs pecuniary cost but also is a constant reminder of the unfortunate and inhumane incident.

The speaker also emphasized that most victims of acid attack are female, with the reasons ranging from personal grudges, jealousy, and revenge to refusal and the like.

DSLISA has included compensation for acid attack victims under Delhi Victim Compensation Scheme.

- Part 1 of the scheme provides compensation for partial deformity in the range of Rs 3 lakh to 7 lakhs. However additional compensation can also be claimed under Part 2 of the scheme.
- In case of permanent deformity, the minimum compensation increases to Rs 5 lakh.
- In case of disfigurement, the minimum compensation shoots to Rs 7 lakh
- Generally, the compensation is provided by DSLISA on application by the victim.



However, DSLISA can also take Suo motu cognizance and disburse the payment. The speaker also pointed out that although Section 326A, 326B of IPC are gender neutral, the rules framed by states presume that only women are victims of acid attack. However, NCRB Report points towards increasing cases of male victims of acid attack as well.

### **NUKKAD NATAK BY NAVMANCH**

The fruitful and informative session was followed by a Nukkad Natak by Nyavmanch to spread awareness about acid Attack. The theoretical knowledge gained by students was underscored by the beautiful performance.





## NATIONAL LOK ADALAT



LAS under the aegis of National Legal Services Authorities Act & Delhi State Legal Services Authorities Act invited application from students of Campus Law Centre for participation in the **National Lok Adalat** in various district courts of Delhi on 11th February, 2023.







The students had the opportunity to witness Lok Adalat proceedings in person and get first hand insight into how the concept of free legal aid envisaged in our constitution under **Article 39A** is brought into application and how litigation happens outside the courtrooms.
