## CALL FOR APPLICATIONS 2023-24

This is to inform all the penultimate year (2<sup>nd</sup> year) and final year (3<sup>rd</sup> year) students of the Campus Law Centre, Faculty of Law, University of Delhi that the IPR Society is soliciting applications for the posts of Student Convenor and Student Co-Convenor for the academic session 2023-24.

### General Eligibility Criteria:

- The applicant must be a *bona fide* student of the Campus Law Centre, Faculty of Law, University of Delhi.
- The applicant must <u>not</u> be an office bearer, convenor, co-convenor, executive member, or any other position holder in any other societies or committees of the Campus Law Centre, Faculty of Law, University of Delhi.

### **Stages of Selection Process:**

**Stage 1:** Interested students <u>are required</u> to submit the following documents (in PDF format):

- 1. Curriculum vitae (not exceeding two pages); and
- 2. Statement of Purpose (Suitability for the post applied for, within 200 words). A student must explain what motivates them to apply for the IPR Society and how will they contribute. Kindly note that the statement of purpose shall be original and not plagiarised.

**Stage 2:** Shortlisted students will be invited for the interview. Further information will be shared via email.

Students must submit the details and duly filled form through Google form link with the subject line 'Application for the post of Student Convenor and/or Student

Co-Convenor' along with the above-mentioned required documents by **10.11.2023; 05:30 pm.** 

Kindly note that incomplete applications will not be accepted. General Registration is must for the students of LL.B. I, II, and III year to join the IPR Society. It is to be noted that general registration is mandatory (precondition) for the applicants for the post of Convener & Co-convener.
