The eligibility Criteria for the post of Convenor and Co-Convenor are:

- Applicant must be a bona fide student of Campus Law Centre.
- Applicant must be a registered and active member of the Legal Aid Society for the academic session 2023-24.
- Applicant must be an **existing PLV or selected in the PLV examination 2024**.
- Applicant must not be an **Office Bearer/ Convenor/Co-Convenor or Executive member** in any other society of Campus Law Centre.

The eligibility criteria for the Executive member are:

- Applicant must be a bona fide student of the First Year of Campus Law Centre.
- Applicant must be a registered and active member of the Legal Aid Society for the academic session 2023-24.
- Applicant must have been selected in the PLV examination 2024.
- Applicant must not be an **Office Bearer/ Convenor/Co-Convenor or Executive member** in any other society of Campus Law Centre.

The interested student may send in their application containing all the following documents:

- Updated Resume
- Filled Application Form (Format of the Application Form has been attached with this notice).
- Proposal for Legal Aid Society for the Academic Session 2023-24. (To be filled only by those applying for the post of Convenor and a printout of the filled proposal should be carried out on the day of the interview)
