### **CALL FOR APPLICATION**

This is to inform you that the Legal Aid Society of Campus Law Centre invites applications for the post of **Student Convener (Only 3<sup>rd</sup> Year PLVs)**, **Student Co-Convener (2<sup>nd</sup> and 3<sup>rd</sup> Year PLVs)**, and **Executive Member (Only 1<sup>st</sup> year PLVs)** for the academic session 2023-24.

**The eligibility Criteria for the post of Convener and Co-Convener are:**

- Applicant must be a bona fide student of Campus Law Centre.
- Applicant must be a registered and active member of the Legal Aid Society for the academic session 2023-24.
- Applicant must be an **existing PLV or selected in the PLV examination 2024.**
- Applicant must not be an **Office Bearer/ Convener/Co-Convener or Executive member** in any other society of Campus Law Centre.

**The eligibility criteria for the Executive member are:**

- Applicant must be a bona fide student of the First Year of Campus Law Centre.
- Applicant must be a registered and active member of the Legal Aid Society for the academic session 2023-24.
- Applicant must have **been selected in the PLV examination 2024.**
- Applicant must not be an **Office Bearer/ Convener/Co-Convener or Executive member** in any other society of Campus Law Centre.

**The interested student may send in their application containing all the following documents:**

- Updated Resume
- Filled Application Form (Format of the Application Form has been attached with this notice).
- Proposal for Legal Aid Society for the Academic Session 2023-24. **(To be filled only by those applying for the post of Convener and a printout of the filled proposal should be carried out on the day of the interview)**
