- Applicant **must have** appeared in PLV exam or provisionally selected as a PLV.
- Applicant **must not be** an Office Bearer/ Convenor/Co-Convenor or Executive member in any other society of Campus Law Centre.

**The eligibility criteria for the Executive member are:**

- Applicant **must be** a bona fide student of First year Campus Law Centre.
- Applicant **must be** a registered member of the Legal Aid Society for the academic session 2025-26.
- Applicant **must have** appeared in PLV exam.
- Applicant **must not be** an Office Bearer/ Convenor/Co-Convenor or Executive member in any other society of Campus Law Centre
