# 3RD MMY MOOT COURT COMPETITION RULES AND REGULATIONS

#### PART-I: TITLE, DATE AND VENUE

Sec. (1) The Maharishi Mahesh Yogi Moot Court Competition 2025, shall be held on 19<sup>th</sup> – 22<sup>nd</sup> November 2025.

Venue: Maharishi Law School, MUIT, Noida, Uttar Pradesh.

#### PART-II: LANGUAGE

Sec. (2) The competition shall be held only in the English Language.

#### PART-III: ELIGIBILITY & TEAM-COMPOSITION

- Sec. (3) The competition is applicable for those students who are pursuing a 5-year Integrated Law Programme OR LL.B (3-year course) OR 6 year B tech LLB Programme OR Company secretary students from any college/institution/university within the territory of India.
- Sec. (4) The team composition, for the competition, shall comprise of either TWO members (being designated as Speakers) OR THREE members (TWO of them shall be designated as Speakers and ONE Researcher).
  Provided that a team may however consist of only TWO members in which case, no member shall be designated as Researcher.
- Sec. (5) Any additional member, as mentioned under Sec. 4, will not be entitled to local hospitality.

  Note (1) No TEAM COACH shall accompany the participating team in the competition.
- Note (2) if any speaker OR researcher is found taking assistance of any kind of unfair means, the team shall stand disqualified from the competition at any stage.
- Sec. (6) The Researcher may be permitted to argue as Speaker in case of illness OR any unforeseen event, the permission of the National Administrator in such case shall be mandatory.
- **Sec. (7)** At any stage of competition Member-Swapping is strictly prohibited (that is any member of a team is requested by another team to plead on their behalf)

#### PART-IV: ACCOMMODATION

**Sec. (8)** Accommodation will be provided on first-come-first serve basis and the amount would be borne by participants and it will be non-refundable on cancelation. Accommodation will be provided on request (Through Email) and advance booking is mandatory to avail the facility.

#### PART-V: REGISTRATION

- Sec. (9) -The registration of the participating teams, for the Maharishi Mahesh Yogi Moot Court Competition, 2025, shall be on a priority basis, that is, receiving the consent letters of the teams by way of Google form in the order of sending first. The preference of registering the teams shall be in the aforesaid manner only. However, the discretion of Dean, Maharishi Law School, shall be final. The participating teams are kindly requested to fill the registration form latest by 5th November 2025. The teams, who have filled their registration forms, shall be deemed to have been registered for the moot court competition. No alteration shall be made once the teams are registered, the intimation of which shall be confirmed by the moot court committee to the teams registered.
- Sec. (10) The last date for sending the registered form shall be 5th November 2025.
- Sec. (11) The date for accepting registration forms shall not exceed the stipulated date as mentioned aforesaid.

#### PART-VI: MODE OF PAYMENT

Sec. (12) - The registration fees for the MOOT COURT COMPETITION shall be Rs. 4000 (Four thousand only) payable through,

#### PART-VII: DRESS CODE

Sec. (13) - The members of participating teams in the competition are mandatorily required to dress up in their formal wear. Dress code shall be Western formals for Gentlemen and Western or Indian formals for Ladies. The teams should make their own provisions to comply with the dress code of the competition.

Note: Any clarifications regarding the moot court competition shall be adhered by the National Administrator in consultation with the moot court committee, the decision of which shall be final.

#### PART-VIII: STRUCTURE OF THE COMPETITION

- Sec. (13) The formal commencement of the competition shall commence from 19<sup>th</sup> November, 2025 with the inauguration and shall conclude with the Valedictory function on 22<sup>th</sup> November, 2025. The structure of the competition is classified as herein under mentioned:
  - The Preliminary Rounds
  - The Quarter Final Rounds
  - The Semi Final Rounds
  - The Final Round

Note: All rounds, as mentioned above, shall be on the basis of Knock- Out.



#### Sec. (15) Preliminary Rounds

- Sec. (15) (1) The Preliminary rounds shall comprise of One Rounds of oral arguments subject to the allotment of team codes. In the preliminary rounds, each team shall have to argue once, as a /Petitioner Respondent or Applicant /Respondent. The preliminary rounds shall take place on 20th November, 2025. The teams shall be escorted to their respective court rooms on the basis of their draw of lots. The draw of lots shall be done in presence of all the participating team by the Moot Court Committee.
- Sec. (15) (2) Once the team code and draw of lots is been disclosed to the teams, it shall be the duty of the respective teams as not to disclose their identity. On the same day i.e. 20th November, 2025 the "Researcher Test" shall take place. Only the Researcher, as indicated in the team registration, shall take the researcher test, the speaker can only take the researcher test if the team comprises only two speakers.
- Sec. (15) (3) The winners of the preliminary rounds shall, i.e. total eight teams (8 teams) s h a I I qualify for the Quarter Final Rounds. The Quarter Final Rounds shall take place on 21th November, 2025 The Teams qualifying to the Quarter Finals shall be on the basis of One Round of Oral arguments of the Preliminary Rounds.
- Sec. 15 (4) The Semi-final rounds shall comprise of four teams. The Semi Final rounds shall take place on 21th November, 2025. The winner of the Quarter final rounds shall be declared qualified for the Semi Final Rounds.
- Sec. 15 (5) The Final Rounds shall take place on 22<sup>th</sup> November, 2025. The two teams who stand declared as winners of the Semi Final Rounds shall qualify for the Final Rounds. Proviso: In case of evaluation of All Rounds the Memorial Marks shall not be included to decide the merit.

Proviso: In case a tie takes place in the Quarter Final, Semi Final or Final Rounds, in that case, the marks of the Preliminary Rounds shall be the basis for deciding the winner.

However, in the Preliminary Rounds, in case the Round Total of the two teams is the same, the team with higher Memorial marks will be credited with a win.

Sec. 15 (6) Evaluation and Time Allocation for All Rounds

I) Preliminary Rounds: 20 minutes for each team

II) Quarter Final Rounds: 25 minutes for each team

III) Semi Final Rounds: 30 minutes for each team

IV) Final Rounds: 50 minutes for each team

#### PART- IX: TEAM CODING

Sec. (16) - The teams, participating in the competition, shall be allotted a TEAM CODE subsequent to the conformation of their registration process. It is to be noted, after the allocation of the team code, to the respective teams, shall be subject to strict confidentiality, the violation which may result in the disqualification of such team. The decision of the Moot Court Committee and National Administrator shall be final in this regard.



#### PART-X: MEMORIAL RULES

- Sec. (17) (1) All teams shall submit 6 Memorials from both sides (Plaintiffs and Defendants).
- Sec. (17) (2) Requirements of the Memorials All teams must submit typed Memorials for both the sides fulfilling the following specifications: The Memorial must contain the following parts:
  - (a.) Cover Page
  - (b.) Table of Contents.
  - (c.) Index of Authorities.
  - (d.) Statement of Jurisdiction.
  - (e.) Statement of Facts.
  - (f.) Issues Involved.
  - (g.) Summary of Arguments.
  - (h.) Body of Arguments/ Arguments Advanced.
  - (i.) Prayer
- Sec. (17) (3) The Memorial Cover Page should follow the following colour scheme Blue for the Plaintiff and Red for the Defendant. Use of decorative cover pages will attract negative marking. The teams are advised to use as far as possible light shades for their cover pages.   - c. The Body of Arguments/ Arguments Advanced shall not be more than 9000 words including all headings, footnotes, headers and footers.

(17) (7) The Memorials should use page size should be A4; Font shall be 'Times New Roman' throughout the document with font size 12 (including headings), 1.5 lines spacing & 1 Inch margin on each side; Footnotes shall be in 'Times New Roman' with Font Size 10 and 1.0 spacing. The Participants may use uniform page borders.
- Sec. (17) (8) The Memorials shall use ILI Citation Rules: A Uniform System of Citation, on for formatting of all cited authorities.



- Sec. (17) (9) The Memorial should be spiral bound only. Any other form of binding will attract negative marking.
- Sec. (17) (10) No amendment of the Memorials will be permitted after submission.

#### MOOT PROPOSITION

The Republic of Bhartim, inspired by India's long-standing constitutional and legal traditions, undertook structural reforms in 2023 to modernize its legal system and respond to technological and societal challenges of the twenty-first century. To this end, the Parliament enacted the Bharatim Nyaya Sanhita, 2023 (BNS 2023), which replaced the colonial-era penal code. Alongside these reforms, Bhartim also passed the Data Privacy and Data Protection Act, 2023 (DPDPA 2023), a comprehensive statute recognizing digital privacy as a fundamental aspect of dignity and autonomy under Article 21 of the Bhartim Constitution. This legislation mandated informed consent for data collection, introduced strict obligations on data fiduciaries to implement transparency and security safeguards, and imposed duties to communicate any data breach to data principals. Both enactments sought to protect individual and collective rights, especially in light of rapid digital advances.

In the state of Pashchim Pradesh, the capital city Vishalya had by 2025 emerged as a leading hub for artificial intelligence innovation. It was in this context that AryaAl Systems Pvt. Ltd., a local technology startup, launched its artificial intelligence platform "JnanaBot" on 1 February 2025. JnanaBot was marketed as an advanced system capable of mining and analyzing indigenous Indian knowledge spanning Ayurveda, Vedic sciences, traditional arts, and community-held cultural practices. AryaAl claimed that the platform's purpose was to generate innovative medical remedies, new technological outputs, and commercially viable patents with global reach. According to AryaAl, JnanaBot's breakthroughs would bring Bhartim both intellectual property advantages and international recognition, while simultaneously preserving traditional wisdom through digitization.

Shortly after the launch, on 10 March 2025, the Bhartim Indigenous Knowledge Council (BIKC), representing a federation of indigenous communities and cultural custodians, lodged a formal objection to the Ministry of Law and IT. BIKC alleged that JnanaBot relied extensively on sacred texts, hereditary practices, and community-held knowledge systems without obtaining prior or informed consent. It objected that the commercialization of these collective resources without any form of benefit-sharing arrangements amounted not only to exploitation but to a violation of dignity and cultural autonomy. In late March 2025, several investigative journalists revealed that JnanaBot's advisory outputs actively promoted expensive pharmaceutical products largely associated with foreign patent holders while undervaluing simple and more affordable traditional remedies available within local communities. Independent researchers connected this bias to skewed training data sets and algorithmic influences introduced through foreign commercial collaborators. On 5 April 2025, further disclosures emerged that AryaAl had failed to maintain



proper protections for cultural and personal data stored within the JnanaBot system. It was revealed that sensitive archives, including metadata linked to knowledge custodians, were left unsecured, creating the possibility of cultural identity exposure. Despite these risks, AryaAl had not issued any breach notifications as required by the DPDPA 2023.

In light of these revelations, the Ministry of Law and IT, Government of Bhartim, initiated prosecution against AryaAl Systems Pvt. Ltd. before the District Court of Vishalya on 2 May 2025. The company was charged under the BNS 2023 for misuse of protected community knowledge, harm caused by negligent Al practices, and acts done with culpable negligence affecting public interest. Simultaneously, violations of the DPDPA 2023 were also alleged, including unauthorized processing of personal and community data, failure to obtain informed consent, inadequate safeguarding of data, and deliberate non-reporting of breaches. The Government contended that AryaAl's actions amounted to statutory violations and simultaneously breached the fundamental rights of equality under Article 14 and privacy under Article 21 of the Constitution of Bhartim, as indigenous communities were deprived of recognition and subjected to data exploitation.

AryaAI, in its defence, argued that no criminal intention could be imputed as JnanaBot functioned autonomously without human control or conscious direction. The company maintained that the use of digitized data, once placed in the public domain, was not expressly prohibited by law for artificial intelligence training. It further asserted that the products generated by JnanaBot were protected under Bhartim's intellectual property laws and that questioning these rights would stifle innovation. With respect to data bias, AryaAI contended that any partiality was merely an unintended outcome of technological limitations and not deliberate negligence. Finally, the company affirmed that it had exercised sufficient compliance with DPDPA 2023 requirements and that any suggestions to the contrary exaggerated minor shortcomings.

On 20 August 2025, the District Court of Vishalya delivered its judgment. The Court concluded that AryaAl's use of indigenous knowledge without express community consent was unlawful under BNS 2023. It held that mens rea, as recognized under the statute, extended to culpable negligence and recklessness in the field of artificial intelligence governance and therefore could be attributed to AryaAl's failures in supervision. The Court found the company non-compliant with DPDPA 2023, observing procedural lapses in the absence of informed consent, the lack of adequate safeguard implementation, and the failure to notify knowledge custodians of breaches. In terms of larger constitutional consequence, the Court ruled that the operation of JnanaBot had undermined both the equality of communities, as guaranteed under Article 14, and their privacy, as secured by Article 21. As remedies, the Court directed a complete cessation of the commercial use of JnanaBot until compliance with consent and data protection norms was established, ordered AryaAl to execute community benefit-sharing agreements, required the adoption of technological corrections to address algorithmic bias, and directed the payment of interim damages to the Bhartim Indigenous Knowledge Council.



Discontented with the ruling, Arya Al filed an appeal before the High Court of Pashchim Pradesh on 15 September 2025. The grounds of challenge included the alleged error of extending the concept of mens rea to cover artificial intelligence outputs generated autonomously without human direction, the misinterpretation of indigenous knowledge protections as restrictions on patent rights granted by intellectual property laws, the flawed finding of DPDPA non-compliance, and the erroneous conclusion that constitutional rights under Articles 14 and 21 had been infringed. AryaAl also questioned the proportionality of the District Court's orders directing cessation of commercial activities and immediate payment of interim damages. The High Court of Pashchim Pradesh, after hearing arguments, substantially confirmed the findings of the District Court while upholding the core remedial directions though with minor modifications. AryaAl, dissatisfied with this outcome, sought further recourse by filing an appeal before the Supreme Court of Bhartim.

Upon admission of appeal, the Supreme Court of Bhartim framed the following issues for adjudication:

- 1. Whether the unauthorized use of community-held indigenous knowledge by AryaAl without prior community consent constitutes a violation of the Bharatiya Nyaya Sanhita, 2023.
- Whether the Jurisprudence of mens rea may be extended to include culpable negligence or recklessness in cases involving outputs of autonomous AI systems.
- 3. Whether AryaAl complied with the statutory obligations under the Data Privacy and Data Protection Act, 2023, specifically in regard to informed consent, data security, breach notification, and protection of the rights of data principals.
- 4. Whether the biased outputs of JnanaBot amount to an infringement of the constitutional rights to privacy and equality, guaranteed to indigenous communities under Articles 14 and 21.
- 5. Whether the District Court's remedial orders—including suspension of commercial use, execution of benefit-sharing agreements, corrective measures to eliminate AI bias, and award of damages—were proportionate, lawful, and justified.

Note: The laws of Bhartim are pari materia to the laws of India

## 3rd MMY CLIENT COUNSELING COMPETITION

#### **ABOUT CLIENT COUNSELING**

The Client counseling Competition encourages better awareness and interest among law students in the counseling and preventative law aspects of legal practice. At the lawyer-client interaction in the legal office, it also pushes students to develop interviewing, planning, and analytical abilities. The majority of lawyers' practice involves both interviewing and counseling clients. This competition aims to improve abilities in areas such as conducting an initial interview with a person who will play the client, attending to the client's legal and non-legal needs, developing a rapport with the client, identifying the client's goals, and taking into account any relevant laws.

#### **ELIGIBILITY**

The competition is applicable for those students who are pursuing a 5-year Integrated Law Programme OR LL.B (3-year course) students from any college/institution/university within the territory of India.

Mode of Competition: Offline

Team Composition: Each team shall consist of TWO members only.

THEME- Artificial Intelligence, Indian Knowledge System and Law

#### FORMAT OF THE COMPETITION

- 1. The participants shall conduct an interview with a person playing the role of the client (Provided by the Host Organization).
- Participants are expected to elicit the relevant information from the client, outlining the nature of the
  problem and to explore the different legal avenues available for providing a solution to the problem with
  means (or range of alternatives) for resolving the same.
- 3. The interview with the client will then be followed by a post-consultation period during which the participants, in the absence of the client, analyze the interview and discuss the legal and other work to be undertaken, during which the presiding Judges may ask them questions, if they deem fit.
- 4. The interview and post-consultation period is for 35 minutes only [25 minutes (Interview) +10 minutes (Post-Consultation)].
- 5. The finalists will be given an extra time of 10 minutes with the client in the final round.
- 6. During the consultation and post-consultation, the team may use books, notes, and bare Acts Only.

#### ROUNDS

There shall be three rounds:

- 1. Preliminary Round: All teams shall compete against each other and the top 10 scoring teams shall be carried forward to the next round.
- 2. Semi-final Round: Top 5 teams from Preliminary Round shall compete against each other and the top 4 out of them shall be carried forward to the next round.
- Final Round: Top 4 teams from Semi-Final Round shall compete against each other and the winner and the runners up shall be declared from them.


