This year it was being observed from **31st October 2022 to 6th November** with the theme of **"Corruption-free India for a Developed Nation"**.

Vigilance Awareness Drive

A Vigilance Awareness Drive was organized by Legal Aid Society, Campus Law Centre on 5th November 2022 near Mukherjee Nagar area to make people aware about their rights and how complaint can be filed against an officer for demanding bribe.

Vigilance Awareness Drive began with the welcome address delivered by Dr. Anita Yadav, Faculty Convener, Campus Law Centre, wherein she extended her greetings to teachers and volunteers in attendance, she thanked everyone and encouraged volunteers to actively participate in drives and events organized by Legal Aid Society and take it to its ultimate goal. Dr. Yadav in her speech told everybody, the purpose that it is being observed throughout the nation for raising awareness among citizens about their rights and duties against corruption. She then acknowledged that most of the people are unaware about this or scared to come forth to file complaint against corrupted officers. She then illuminated about Central Vigilance Commission and also about PIDPI resolution mechanism in which the identity of the complainant is kept secret and protected from victimization for making such complainants.

Dr. Yadav concluded her speech with an uplifting message that “always be a responsible citizen and never ever involve in accepting or offering bribe” and requested everybody to take **Integrity Pledge**.

She then handed over the floor to Shashank, Co-Convener, Legal Aid Society who briefed the volunteers about Vigilance Awareness that Central Vigilance Commission provides facilities to citizens like PIDPI which stands for Public Interest Disclosure Protection of Informer, where the informer is granted protection in case of reporting of corruption in public interest. Shashank further made a brief that citizens can send a corruption complaint against Corporation made under Central Acts, Government Companies or Society or Employees via post to Secretary, CVC or PIDPI without disclosing the identity (Name and Address) of complainant.

Volunteers then visited Mukherjee Nagar area where they distributed pamphlets and made people aware that they can file complaint to CVC without disclosing their name and residence, if any officer in power had ever demanded bribe.

A large number of students and teachers showed their support by taking the E-pledge.
