**About the Chief Guest:** Prof. Upendra Baxi was awarded the Padma Shri in 2011, the fourth highest civilian award in India, by the Government of India. He has been the Vice-Chancellor of the University of Delhi from 1990–1994, prior to which he held the position of Professor of Law at the Faculty of Law, University of Delhi for 23 years and also served as the Dean of the Faculty of Law, University of Delhi from 1975 - 1978. He has also served as the Vice-Chancellor of the University of South Gujarat, Surat, India from 1982–1985. He is a renowned legal scholar, since 1996 Professor of Law at the University of Warwick, United Kingdom. As an author, he has written innumerable articles and books.
